

Terms and Conditions

For officials registration for the season 2024-25

- i. I hereby confirm that I am wholly responsible for all details that I shall provide during the registration process and that I am required to submit the same not later than 20 of Sep 2024.
- ii. I understand, once I have selected the activity that I wish to be associated with Oman Cricket for the season 2024-25, I shall not request for any change. However, Oman Cricket may assign me for another activity closer to the date of the match, should I be not already assigned.

For the sake of clarity, I have selected to be an Umpire at the time of registration, but, if Oman Cricket wishes to assign me for scoring on a particular day, then, I shall be available.

- iii. I understand that the assignments for the whole season shall be done before the start of the season and once assigned OC shall not make any changes except under unavoidable circumstances and when matches are postponed by OC. For those new tournaments that start later (such as T20 Knockout or where the second round of the same league matches are scheduled later on) the assignments will be done once the schedules are released.
- iv. I understand that the assignment process will be handled by a software solution developed specifically for Oman Cricket match official's assignments. Once I have accepted the assignment I shall not request for any changes unless under the following circumstances, latest by five days before the assignment.
 - a) I am likely to be out of Muscat or the country
 - b) Due to official assignments at place of work
 - c) Ill health (self or anyone within the immediate family)
 - d) Any other unexpected and unavoidable circumstances.

I understand that I will have to provide a proper reason for rejecting the assignment closer to the match date.

- v. I understand that once I am assigned, I will be intimated by Oman Cricket on my registered email id (email id used at the time of registration) and that I will be required to accept or reject the same for the whole season latest by the time provided at the time of assignments. I also understand that there shall be no communication on WhatsApp for assignments either by OC or by me.
- vi. I understand that a document containing the guidelines to use the Oman Cricket Officials Assignment Management System will be distributed before the start of the season and I confirm that I shall follow all the guidelines without fail.
- vii. I confirm that I shall not under any circumstances either misuse the application or negatively criticize the application in public / social media. If I found to be involved in any such activities or other activities that could bring disrepute to the game of Cricket in Oman or to Oman Cricket, I would be liable for any disciplinary action.
- viii. I hereby confirm that I shall only interact with Mr. Rahul Asher, Umpires Development Officer and Educator, for any clarification or assistance. I also understand that any interpretation of the guidelines by anyone other than Mr. Rahul Asher shall not be acceptable in case if any dispute.
- ix. I understand that Oman Cricket shall reserve the right to make any changes to the assignments application either before the start or during the season. It is also clear that Oman Cricket shall be solely responsible for development, maintenance and upgrade of the application.
